# INSTRUCTIONS FOR BLANKET EXEMPTION FORMS

To our Customers,

If you wish to make tax-exempt purchases with our company without filling out a form each time, you will need to submit to us a Blanket Exemption Certificate. Until we receive an approved form, we are required to charge sales tax on all your purchases. It is not a problem for your account to be set up as tax-exempt, we just need the proper forms for our records.

It is important the form is filled out completely and correctly.  
We cannot accept incomplete forms.

1. Check the box which describes the reason for your exemption;
  - a. If none of the choices are appropriate, use the write-in area. If you use the write-in area, please be specific. Do not use General terms such as; manufacturing, or resale, or farm use. Those reasons are all covered in the checkboxes. The State wants specific detail if you use the write-in area stating how you are going to use the materials. If you have any questions, contact your accountant or our office.
2. Print your company information in the Purchaser's Information area;
  - a. It is important you fill out every field. If you do not have a company name, use the owners' name. If you have a company name, use both. It is important that either, the company name, or the owner's name matches the name used on all our invoices to you.
3. Sign, title, and date the form.
